



PUBLIC NOTICE

Tax Identification Number (TIN) Requirement for All Importers **Effective Date: February 2, 2026**

The Belize Tax Service hereby notifies the general public that, effective February 2, 2026, all persons importing goods into Belize will be required to possess and provide a valid Tax Identification Number (TIN).

Who is Affected?

This requirement applies to ALL importers, including but not limited to:

- One-time importers and irregular importers
- Members of the Belizean diaspora (Belizeans returning from abroad to reside in Belize)
- Participants in the Qualified Retirement Program (QRP)

How to Register for a TIN?

All persons who do not currently possess a TIN may register conveniently online through the IRIS Belize Platform-<https://irisbelize.bts.gov.bz>

The online registration process is simple, secure, and accessible 24/7. All applicants are encouraged to complete their registration well in advance to ensure uninterrupted importation activities.
